

Wayhome Ticket Giveaway Contest - Official Rules (the "Rules")

1. The sponsor of this contest is Fource Entertainment (the "Contest Sponsor").
2. **ELIGIBILITY.** The Contest is open to residents of Canada (excluding residents of Quebec) who are age of majority or older in their province/territory of residence at the time of entry and who work reside in Canada (excluding the residents of Quebec).
3. **CONTEST PERIOD, HOW TO ENTER AND NO PURCHASE NECESSARY.** The Contest will commence in the Contest Regions at 12:01am EST on July 11, 2017 and will run until 4:00pm EST on July 14th, 2017. To enter, follow the instructions on the associated "Hive.co" contest landing page.
